No interference shall be caused to any Radiocommunication station or service and no protection from interference by such stations or services shall be afforded.

This licence authorises the licensee to operate on the channel centre frequency of 2187.0 MHz with a maximum bandwidth of 8.0 MHz and a transmitter power up to 100 mW into a 3.0dBi antenna, in Queensland (4).
