## Conditions of operation

- (1) The licensee must not operate a radiocommunications device under this licence that is not an earth station.
- (2) The licensee must not cause harmful interference to an existing or future radiocommunications receiver communicating with a transmitter operated under another area-wide licence (the other licence) which was first issued before this licence and authorises operation in the same frequency range and geographic area as this licence, if that receiver is located within an area authorised by the other licence and is operating in the frequency range:
  - a) 24.7 - 27.5 GHz, or
  - b) 27.5 - 28.1 GHz inside an area subject to the *Radiocommunications (Spectrum Re-allocation - 26 GHz band) Declaration 2019*.
