# **Special Conditions applying to Station 1**

An efficient ferrite isolator must be fitted between the transmitter and the antenna.

An efficient cavity filter must be fitted between the transmitter and the antenna.

The level of power in the adjacent channel must not exceed -16dBm.

No interference shall be caused to any Radiocommunication station or service and no protection from interference by such stations or services shall be afforded.
