Special Conditions applying to Station 1

The level of power in the adjacent channel must not exceed -16dBm.

The level of all discreet spurious components, measured at the output of the transmitter, must not exceed -30dBm.

This licence limits the operation of the service to within 100 metres of the coordinates of the site recorded on the licence. Use of the service beyond this radius is not permitted.

The system authorised by this licence must not cause harmful interference to the system authorised by Licences 1932260/1 and 1941745/1, operating on 490.35/495.55 MHz, 490.3625/495.5625 MHz, respectively, on ACMA Site 11597.
