Advisory Notes applying to Station 1

The availability of additional channels in this trunked land mobile service system is dependent on the licensee demonstrating that loading criteria appropriate to the system have been reached. Information about appropriate loading criteria may be obtained from the Australian Communications and Media Authority.

Special Conditions applying to Station 1

Mobile to mobile communications authorised under this licence must not cause interference to any radiocommunication station or service and no protection from interference to mobile to mobile communications by such stations or services shall be afforded.

When the transmitter is coupled to an antenna the level of all discrete spurious components caused by the transmitter & measured at the connection to the antenna must not exceed -30 DBM. Broadband noise floor of the transmitter measured at the same point must not exceed -47 DBM in a 16 kHz bandwidth for frequency offsets greater than 300 kHz from the transmit frequency.

The level of power in the adjacent channel must not exceed -16dBm.
