Special Conditions applying to Station 1

The level of power in the adjacent channel must not exceed -16dBm.

When the transmitter is coupled to an antenna the level of all discrete spurious components caused by the transmitter & measured at the connection to the antenna must not exceed -30 DBM. Broadband noise floor of the transmitter measured at the same point must not exceed -47 DBM in a 16 kHz bandwidth for frequency offsets greater than 300 kHz from the transmit frequency.

The system authorised by this licence must not cause harmful interference to, nor claim protection from, the system authorised by Licence 1212921/1 operating on 413.35/403.9 MHz at ACMA Site 202250.
