# Advisory Notes applying to Station 1

Actual transmission is expected to be from an antenna height and HRP which will exceed the LAP specification. Regulatory forbearance permits transmission from 126 m with max ERP of 200W and relaxed radiation pattern specification until LAP is varied.

## **Special Conditions applying to Station 1**

The service is interference limited, only field strength levels of 66dBuV/m and above will be protected from interference.
