Special Conditions applying to Station 1

The coverage area of this transmission is described as that area within a radius of 30 kilometres measured from a point with the following AMG co-ordinates: Zone: 56; Easting: 357100; Northing: 6311200. This point is the same as the nominal transmitter site as specified in the Gosford Radio Licence Area Plan.

The cmf at all elevations is not to exceed the specified cmf at 0 degrees elevation for all angles of azimuth.
