### **Special Conditions applying to licence no.: 1170001/1**

The licensee must ensure that no harmful interference shall be caused to the operation of any radiocommunication station or service. If the operation of the transmitter is causing interference to other services, the licensee is required at the licensee's own expense, to adjust, or fit devices to, receivers in order to eliminate or minimise that interference. This licence must only be used for the purpose of providing an open narrowcasting service, as defined in section 18 of the Broadcasting Services Act.

the licensee, or any person authorised by the licensee to operate a radiocommunications transmitter under the licence, must commence to provide an open narrowcasting service under the licence within six months of being issued the licence, or within such longer period as is notified in writing by the Australian Communications and Media Authority.

The licensee, or any person authorised by the licensee to operate a radiocommunications transmitter under the licence, must follow the start-up procedure set out in Part 1 of the Technical Planning Guidelines determined under section 33 of the Broadcasting Services Act, as though references in that Part to a section 102 broadcasting service were references to an open narrowcasting service provided pursuant to this transmitter licence, and references to the licence area of the licence were references to the coverage area of this transmitter licence.

#### Advisory Notes applying to Station 1

Any transmission in accordance with this specification is planned on the basis that it will be protected to a minimum median field strength level of 66 dBuV/m against interference from other broadcasting services.
