Special Conditions applying to licence no.: 1170205/1

This licence must only be used for the purpose of providing an open narrowcasting service, as defined in section 18 of the Broadcasting Services Act 1992.

The licensee, or any person authorised by the licensee to operate a radiocommunications transmitter under the licence, must commence to provide an open narrowcasting service under the licence within six months of being issued the licence, or within such longer period as is notified in writing by the Australian Communications and Media Authority.

The licensee, or any person authorised by the licensee to operate a radiocommunications transmitter under the licence, must follow the start-up procedure set out in Part 1 of the Technical Planning Guidelines determined under section 33 of the Broadcasting Services Act 1992, as though references in that Part to a section 102 broadcasting service were references to an open narrowcasting service provided pursuant to this transmitter licence, and references to the licence area of the licence were references to the coverage area of this transmitter licence.

The 'coverage radius' of this transmission is 5 kilometres measured from a point with the following AMG co-ordinates: Zone: 56; Easting: 235870; Northing: 6024180. This point is not the same as the nominal transmitter site.

Any transmission in accordance with this technical specification is planned on the basis that it will be protected to a minimum median field strength level of 66 dBuV/m against interference from other Broadcasting Services.
