The licensee, or any person authorised by the licensee to operate a radiocommunications transmitter under the licence, must follow the start-up procedure set out in Part 1 of the Technical Planning Guidelines determined under section 33 of the Broadcasting Services Act 1992, as though references in that Part to a section 102 broadcasting service were references to an open narrowcasting service provided pursuant to this transmitter licence, and references to the licence area of the licence were references to the coverage area of this transmitter licence.

The 'coverage radius' of this transmission is 10 kilometres measured from a point with the following AMG co-ordinates: Zone: 55; Easting: 615200; Northing: 5960400. This point is the same as the nominal transmitter site.
