## **Special Conditions applying to licence no.: 1188158/1**

The licensee, or any authorised person, is required to place advertisements in newspapers circulating within the licence area of the licence at least seven days before the commencement of transmissions. Sections 1, 2, 3 and 5 of Part 1 of the Radiocommunications Licence Conditions (Apparatus Licence) Determination 2003, as in force from time to time, do not apply to broadcasting licences (broadcast service stations) that authorise the operation of transmitters to provide a commercial broadcasting service or a community broadcasting service.

Under section 109(1)(e) of the Radiocommunications Act 1992, it is a condition of this licence that the licensee, and any person authorised by the licensee to operate the radiocommunications transmitter under this licence, must comply with the technical planning guidelines developed by the Australian Communications and Media Authority under section 33 of the Broadcasting Services Act 1992.
