## Advisory Notes applying to Station 1

The paging transmitter authorised by this licence has been licensed on the condition that the licensee accepts any mutual interference that occurs between this and any other paging service licensed to them on the same frequency within 100km.

For conditions of licence relating to exterior paging operation please refer to the attachment entitled Conditions Of Licence For Exterior Paging Station Licences Issued under the Radiocommunications Act 1992.

## Special Conditions applying to Station 1

When the transmitter is coupled to an antenna the level of all discrete spurious components caused by the transmitter & measured at the connection to the antenna must not exceed -30 DBM. Broadband noise floor of the transmitter measured at the same point must not exceed -47 DBM in a 16 kHz bandwidth for frequency offsets greater than 300 kHz from the transmit frequency.

The level of power in the adjacent channel must not exceed -22dBm.
