No interference shall be caused to any Radiocommunication station or service and no protection from interference by such stations or services shall be afforded.

This licence is authorised subject to Spectrum Embargo No. 11., Operation is not permitted within 350 kms of an area contained within a circle segment of radius 225 kms centred on Nowra Airfield, NSW whose boundary is described by the limits of a 90 degree arc with axes extending 225 kms EAST and SOUTH from the centre.
