### Special Conditions applying to Station 1

1. The licensee must only communicate with the licensee's paging receivers or mobile stations; and
2. The licensee, when using a low frequency inductive loop, must not cause interference to any Radiocommunications station or service and no protection from interference shall be afforded; and
3. Emissions from interior paging transmitters must be confined, as far as practicable, to within the limited area to be served.
