Special Conditions applying to Station 1

The level of all discreet spurious components, measured at the output of the transmitter, must not exceed -30dBm.

The level of power in the adjacent channel must not exceed -16dBm.

The licensee authorised by this licence is permitted to operate with the temporary frequencies 79.105 MHz Base TX / 78.295 MHz Base RX and emission 16K0F3E until the cessation date of 1 NOVEMBER 1996. Such temporary operation is on a secondary basis only and must not cause harmful interference to stations operating on a primary basis. After the cessation date, the apparatus pertaining to this licence must comply with the primary technical operating conditions specified on this licence.
