Certain information contained in this licence record will be disclosed in the Register of Radiocommunications Licences (RRL), established and maintained pursuant to Part 3.5 of the *Radiocommunications Act 1992*.

Special Conditions applying to licence no.: 1703576/1

The received signal in any area zoned residential (as determined by the Australian Bureau of Statistics data for towns and cities) shall not exceed 48 DBUV/M measured at a height of 10 metres above ground at any location more than 1 km from the antenna.

The licensee must comply with the emission standard for the Australian Frequency Modulation Sound Broadcasting Service.

This licence can only be used to provide a low-power open narrowcasting service.

This licence is issued or renewed only for the period for which the frequency has been made available under section 34 of the Broadcasting Services Act 1992.

The licensee, or any person authorised by the licensee to operate a radiocommunications transmitter under the licence, must follow the start-up procedure set out in Part 1 of the Technical Planning Guidelines determined under section 33 of the Broadcasting Services Act 1992, as though references in that Part to a section 102 broadcasting service were references to an open narrowcasting service provided pursuant to this transmitter licence, and references to the licence area of the licence were references to the coverage area of this transmitter licence.

If the operation of the transmitter causes interference to the reception of any Broadcasting Service the licensee is required, at the licensee's own expense, to take all reasonable steps to resolve the interference problem. The licensee may be directed by ACMA to cease operation until the interference problem is resolved.
