An efficient ferrite isolator must be fitted between the transmitter and the antenna.

An efficient cavity filter must be fitted between the transceiver and the antenna.

No interference shall be caused to any Radiocommunication station or service and no protection from interference by such stations or services shall be afforded.

All necessary measures must be taken to ensure there is no interference or disturbance to or from existing co-sited CFA services on the following frequencies: 161.1 MHz, 161.1125 MHz, 161.175 MHz and 161.2MHz
