Conditions applicable to the operation of Narrowcasting Service station(s) authorised under this licence can be found in the Radiocommunications Licence Conditions (Apparatus Licence) Determination and the Radiocommunications Licence Conditions (Broadcasting Licence) Determination. The frequency band 87.5 to 88 MHz is made available for low power open narrowcasting radio purposes under section 34 of the Broadcasting Services Act 1992. The ACMA's Determination of Radiofrequency Spectrum makes this spectrum available until 31 December 2020. The ACMA cannot authorise the operation of a low power open narrowcasting radio service using this frequency beyond this date. The ACMA will review the use of this spectrum before 31 December 2020.

Special Conditions applying to Station 1

The licensee, or any authorised person, is required to place advertisements in newspapers circulating within the licence area of the licence at least seven days before the commencement of transmissions. The advertisement should state that members of the public should contact the licensee, or authorised person, if the broadcast causes interference to other radiocommunications. The advertisement must detail the date and the time of the commencement of transmissions, the frequency being used and the appropriate person's contact details, including the address and telephone number of the person responsible for the transmissions.
