### Special Conditions applying to licence no.: 1928531/1

The licensee, or any authorised person, is required to place advertisements in newspapers circulating within the licence area of the licence at least seven days before the commencement of transmissions. The advertisement shows state that members of the public should contact the licensee, or authorised person, if the broadcast causes interference to other radiocommunications. The advertisement must detail the date and the time of the commencement of transmissions, the frequency being used and the appropriate person's contact details, including the address and telephone number of the person responsible for the transmissions.

The licensee must comply with the emission standard for the Australian Frequency Modulation Sound Broadcasting Service.

The licensee must ensure that no harmful interference shall be caused to the operation of any radiocommunication station or service. If the operation of the transmitter is causing interference to other services, the licensee is required at the licensee's own expense, to adjust, or fit devices to, receivers in order to eliminate or minimise that interference This licence must only be used for the purpose of providing an open narrowcasting service, as defined in section 18 the Broadcasting Services Act 1992.

the licensee, or any person authorised by the licensee to operate a radiocommunications transmitter under the licence, must commence to provide an open narrowcasting service under the licence within six months of being issued the licence, or within such longer period as is notified in writing by the Australian Communications and Media Authority.
