Advisory Notes applying to Station 1

The shared spectrum arrangements and uncoordinated nature of class licensed radiocommunications devices in the 1880-1900 MHz band:

- a. may result in interference from nearby class licensed radiocommunications devices that may reduce system performance; and

Special Conditions applying to Station 1

2. The non-directional base receiver authorised by this licence may experience interference from licence 1408852 Tx at site 401132, and is only protected to a level of -81.6 dBm/10 MHz (LOS propagation).

3. The non-directional base receiver authorised by this licence may experience interference from licence 77393 Tx at site 14787, and is only protected to a level of -85.8 dBm/10 MHz (LOS propagation).
