The licensee, in operating the device(s) authorised by this licence, must comply with the conditions that were imposed by the licence that previously authorised the operation of the device(s).

When the transmitter is coupled to an antenna the level of all discrete spurious components caused by the transmitter & measured at the connection to the antenna must not exceed -30 DBM. Broadband noise floor of the transmitter measured at the same point must not exceed -47 DBM in a 16 kHz bandwidth for frequency offsets greater than 300 kHz from the transmit frequency.
